Dear Board of Directors:

The Lake Mission Viejo Yacht Club is interested in becoming an entity under the auspices of the Lake Mission Viejo Association. There are two primary reasons for this interest:

- 1. LMVYC goals have changed, so independence is no longer necessary or desirable, and;
- 2. the cost of the club's liability insurance has become prohibitive.

The insurance mentioned in item 2 above is required by LMVA if LMVYC is to continue to hold invitational regattas at Lake Mission Viejo. It is my hope that as a special activity under LMVA, an endorsement covering LMVYC can be added to the LMVA liability policy for a small premium. If so, the club can contribute some money to help cover this premium.

We hold only three invitational regattas each year, with sailors from all over Southern California coming to race on and enjoy our beautiful lake. If the club cannot obtain low cost liability insurance, we will have to cancel these events, including the event scheduled for March 23.

As a special activity under LMVA, the LMVYC would propose to collect a member-ship fee from each member and forward these fees to LMVA for deposit in a LMVA account. The club would then draw funds from this account for the following purposes:

- maintain racing equipment;
- 2. cover the cost of trophies;
- 3. help defray the cost of a yearly banquet;
- 4. help cover the cost of insurance endorsement, and;
- 5. help cover fuel costs for the club's use of the IMV pontoon boat during regattas.

I have held some discussions with LMV Manager, Bill Schwartz, concerning the above, and I will attend the LMV Board of Directors meeting on March 12 to discuss this with you. If an agreement can be reached at that time and the insurance problem settled before March 23, LMVYC will be able to host the invitational regatta scheduled for that day. Otherwise, we must cancel it and one scheduled for the fall.
